Hospira, Inc. was an American global pharmaceutical and medical device company headquartered in Lake Forest, Illinois. The company specialized in generic injectable pharmaceuticals and integrated infusion therapy systems for hospitals and alternate care settings. Hospira maintains an FDA 510(k) regulatory record of cleared devices from total submissions between 2004 and 2017. The company's primary focus was General Hospital devices, which comprised the majority of its submissions.
