Now part of Boston Scientific, the company is based in Saint Paul, Minnesota, with historical operations in McHenry, US. The company received FDA 510(k) clearances from total submissions between 1977 and 2010. Cardiovascular devices dominated the regulatory portfolio at 83% of submissions. This historical record reflects the company's core focus on cardiac rhythm management and related interventional technologies. CPI developed t...
