The company received FDA 510(k) clearances from total submissions between 1977 and 2010. Cardiovascular devices dominated the regulatory portfolio at 83% of submissions. This historical record reflects the company's core focus on cardiac rhythm management and related interventional technologies. CPI developed t...
